- 8. Submission of an application does not guarantee the opportunity to audition or participate in the competition.
- 9. The Organiser's team may film and record performances at the associated events and may use them for marketing and promotional purposes. The Organiser will not own the intellectual property rights of any film and sound recording of the performances but reserves the right to its use as outlined above.
- 10. The Contestant is free to enter to this agreement and hereby agree to indemnify the Organiser in respect of all actions, proceedings, claims, damages and other liabilities which may be brought against or incurred by the Organiser as a result of the breach of any of the contestant's warranties, representations or obligations contained in this agreement.
